The updated Resource Report 1, Appendix 1-A alignment sheets are being finalized and will be filed next week. Mountain Valley will provide the Pipeline Stream Crossing Burial Recommendations¹ in a supplemental filing in the second quarter. The geotechnical investigation of the Sandy River crossing has been delayed due to access issues. Mountain Valley expects to provide the results of this investigation in a supplemental filing in the third quarter.
